H. PLE COUPLER FOR LX4000 SYSTEMS

(Meet specifications as ref. 76604US or exceed). Measures the rapidly occurring relative changes in pulse blood volume. The photoelectric plethysmograph utilizes a photosensitive cell to measure light reflected or passed through the tissue segment where the monitor is placed. The light source used produces a light in the infrared range (7000 to 9000 Angstroms). The light in this frequency is scattered by red blood cells so the amount of light reaching the photo sensor is related to the amount of blood through which it passed before reaching the sensor. The sensor can be placed on the same side of the monitoring site as the light, in which case the amount of light reflected back is measured. A clamp-like device houses both the light source and the sensor, and the assembly is placed on the finger or the thumb. This Plethysmograph has one primary connector that plugs into any of the auxiliary inputs on the LX4000 Computerized Polygraph.

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
